*Last year South Carolina shattered records in supporting InsurPac, and we can't thank you enough!*

Usually states are recognized for averaging contributions of \$100 per agency, but South Carolina doubled that averaging \$200 per agency. We meant it when we said to "Give what you can," that every dollar counts, and our receipts reflect it. Thanks to your support, SC had the most contributors AND the largest increase (+\$10,675) in total contributions than any other state.

## National records broken

South Carolina wasn't alone in stepping it up for InsurPac. Last year was a record-breaking year nationally as well. They broke records with total contributions of more than \$1.11 million dollars; a record number of states earned Eagle Awards by averaging \$100 or more per member agency; and a record number of Young Agents contributed a record total of \$139,118 to the overall amount.
