Certified Insurance Service Representative

The **Certified Insurance Service Representative (CISR)** program is excellent for ALL agency and company personnel. The CISR courses emphasize the understanding and analysis of property/casualty risks and exposures. The program consists of 9 one-day courses followed by an **optional** exam. Successful completion of **5 (five)** of the 9 courses & their exams earns students the prestigious CISR designation.

No exam is necessary to receive CE credit.

CISR Update Requirement

Holders of the CISR designation must attend either a CISR course, a William T. Hold Seminar or a Dynamics of Service seminar each year **or** 8 continuous hours of a CIC institute in order to keep the CISR designation. Attending an entire CIC institute will update the CISR designation for 2 years. Designation holders are **not** required to re-test each year.

****William T. Hold seminars and Dynamics of Service Seminars qualify as a CISR update, but they DO NOT count toward the CISR designation.****
